MISSION

With over 40 years of experience, Providence House is a leader in helping people overcome challenges and gain independence in the community. We advocate for women and families at risk of harm who have histories of homelessness or justice involvement, and provide them with a safe environment where their dignity is recognized, strengths are enhanced, and a transition to stability is achieved.

OUR SERVICES

In recognizing that many of those who come to us for help do so with histories of trauma, Providence House utilizes the Sanctuary® Model, which promotes safety and recovery from adversity through the active creation of a trauma-informed community. This approach allows us to go beyond a simple exchange between "client" and "service provider" and instead creates an emotionally safe and supportive space for residents to heal and grow.

TRANSITIONAL SHELTER PROGRAM

Our Transitional Shelter Program provides emergency housing, engaging residents for six to eight months. During this time, our team works closely with each person to address issues such as accessing a primary care physician, securing a stable source of income, and obtaining appropriate childcare as well as linking them to permanent housing.

PERMANENT SUPPORTIVE HOUSING

Our Permanent Supportive Housing is designed for families and single adults who have histories of chronic homelessness, serious mental illness (SMI), and/or Substance Use Disorder (SUD). Through our case management and clinical services, we assist residents in developing selfsufficiency skills while providing them with tools and training to become independent.

WOMEN'S JUSTICE PROGRAM

Our Women's Justice Program serves women experiencing homelessness who would otherwise be held at Rikers Island while awaiting trial. We provide staff onsite 24 hours a day, ensuring access to substance use or mental health treatment, life skills training including financial literacy and budgeting, and any parole, probation, or court-mandated services.

AFTERCARE SERVICES

Our doors are always open to former residents. We strive to connect our residents to aftercare support, mentoring programs, and ongoing linkage and referral services after they leave our program. We also provide opportunity for people to return to us if they experience setbacks in their journey to independence.



PROGRAM EXPENSES

For every dollar invested in Providence House, **84 cents directly** supports our program participants.



FINANCIAL GROWTH

Over the past six years, Providence House has more than tripled its revenue, growing in size from \$5.4 million in 2018 to \$16.7 million in 2023. In that time, our program capacity increased 190% from 232 people served in FY 18 to over 650 people in FY 2023.
